(1) Welcome & Introductions Pat and Joel	Joel gave regrets from Pat who is sick with the flu. Due to the uncertain weather in the triangle area and icy/snowy weather west and north of this area, folks have sent regrets for today's meeting. All were welcomed and introductions made. (2) Review of minutes and agenda Pat and Joel	Joel indicated his student completed Jan 11 th meetings and he will send these to Susan. Will be sent out next meeting.	Will be sent and posted on the web once reviewed.
(3) Cooperative Extension and Related NSCU Child and Family Initiatives - Presentation by Dr. Karen DeBord, Professor and Extension Specialist in Child Development at NCSU and Dr. Andrew Behnke, Assistant Professor and Extension Specialist in Human Development at NCSU	Dr. DeBord (Karen), indicated she had first worked with Susan Robinson, DMHDDSAS, during the response to Hurricane Fran and then Floyd and have continued to work on common areas in promoting healthy child and family relationships since. Dr. Andrew Behnke, has just begun working with Karen at NCSU and may continue to participate in the State Collaborative. North Carolina Cooperative Extension is an educational partnership helping people put research-based knowledge to work for economic prosperity, environmental stewardship, and an improved quality of life. It is carried out by Masters level educators in 100 counties plus the Cherokee reservation. Each county has an extension office — http://www.ces.nesu.edu/counties The Department of 4-H Youth Development and Family and Consumer Services services the educational and referral needs of the WHOLE Family. Outreach programs include those related to family well-being addressing areas such as nutrition and health, stress and coping, transitions, child development and parenting. NCSU and UNC-G offer a joint Master of Science in Human Development and Family Studies with a Concentration in Family Life and Parent Education. A person can earn this degree as a full-time student or while working full-time. 4-H runs some after-school programs such as the Governor's SOS program where trained field staff look at the family more holistically. They also do train the trainer programs. Dr. DeBord asked about the multi-agency Child and Family Team training and how Cooperative Extension might be involved. After discussion, it appeared the only possible problem might be third party payment. She is willing to discuss that with Dr. Terri Shelton at UNC-G to see how this issue might be resolved after reviewing the training. 4-H and Cooperative Extension is also looking for partners for Leadership Development and peer-to-peer support. Joel suggested that she talk with UNCG about NC Families United, which might be a partner for family coac

This is an evidence-based substance program that Kate B. Reynolds has entered into an agreement with Robert Wood Johnson. There is not a lot of money but good technical assistance for six communities in North Carolina. Dr. Terri Shelton from UNC-G will get information on this grant and Paul Savery will update the State Collaborative on it at its meeting on March 14th.

Carol Kyles reported on a two year grant that School-Based School Linked Health Centers received. She and Joel had a meeting with the partners involved with this grant. They are using SOC principles and want to do more through the State Collaborative. They did a needs assessment and found that how to get money and training was the biggest area. They found that mental health with mental health reform and learning about other systems such as MRS was necessary. Their next meeting is March 7th and will try to coordinate future meetings with the State Collaborative's meetings.

Diann Irwin reported that the Assistant Secretary of the U.S. Department of Education was coming to Raleigh on February 25th to learn about what North Carolina is doing with Positive Behavior Supports (PBS) and visit two Wake County schools using the program.

Diann reported on a meeting of people who deliver behavioral services to pre-school children (DCD, DMHDDSAS, DPH, NCICC, Smart Start and More at Four, etc.) that was held on February 13th. It was obvious at the meeting that licensed child care facilities receive training but that there is little other training provided to promote healthy social-emotional development. Susan had asked Diann and Norm to include Deborah Nelson, DPH, with ECCS (Early Childhood Coordinated System MCH grant in last year of grant.) Deborah has presented updates on the shared school readiness indicators last year to the Collaborative. The Office of School Readiness in DPI will probably continue these meetings.

SOC – MeckCares – Positive Behavior Support (PBS) – following the statewide conference in December the SOC Coordinators and PBS Regional Coordinators and DPI EC Behavioral Consultants met together in Charlotte. MeckCares access TA time with Sandy Kenan, to facilitate this meeting. This is a beginning conversation and info exchange for SOC Coordinators to learn about PBS, to know which LEA's are implementing PBS and what they could do to encourage those who did not have it to participate. The opportunity to promote PBS and SOC as a coordinated effort

DPI is undergoing re-organization. They are re-designing work model to improve academics and free up more staff to go to the schools to help them improve. Diann asked where the final state collaborative Charter was. Joel indicated it was on the web site. Diann indicated she needed it for work purposed to show why she needed to continue to attend the State Collaborative. Joel said that we need health data, which could be linked to educational data to provide outcomes to schools. There are two reports currently done that might facilitate that — the Annual School Nurse Report, which is not linked to the
