Editing is the next step, getting online pieces together, will be doing a pilot study with SC members to make sure it makes sense to all. Will link to the website.</p> <p>Trauma Workgroup-DJJP justice group is doing trauma awareness and interventions in the juvenile justice. Looking at kids at YDCs, providing them with SPAs and help them when they re-enter the community. Grant only allows for work with juveniles with misdemeanors.</p> <p>Paul is working with SA residential programs to increase trauma awareness and interventions.</p> <p>School Based Behavioral Health Workgroup- strategic plan for state-wide BH, to review and determine next steps. Will be April 21, 2010 in Raleigh. Already have 37 positive respondents and not even including work-group...will help reimburse attendees whose agencies can’t afford to send them.</p> <p>CFT training for Sayso Youth, so youth understand the need/process of CFT, has been moving along. Sayso will provide a summary of this work on their website and then SC will link to their site.</p> <p>Question: Do we want to establish a Marketing committee through Training and TA that would document SC successes, and promoting SC endeavors that are available to the public?</p> <p>Discussion was had about the need for training our college/grad students in the practical applications of their trade/field.</p> <p>The Training and TA Committee with Mark O’Donnell was looking into this with regards to training in SOC.</p> <p>Some other ways to incorporate practical training into traditional education:</p> <ul style="list-style-type: none"> • pre-service inter-disciplinary training via college/univ. faculty • licensure requirements, • allowing CFT, SOC, PBS modules for students to do as extra-credit

Should SC evaluate CFT trainings??? — The new Medicaid Definitions for Day Treatment and Intensive In Home requires providers to have 8 hours of system of care and 8 hours of CFT training

SC game plan long-term: Training and TA committee will discuss and determine process.

Question: It was brought to the SC attention that some entities who have worked with the State Collaborative and provided CFT training are not "officially" recognized on the Division's approved trainer list. Should they no longer provide trainings until they are given further direction?

SC determined: For those trainers who have been doing CFT with the training committee, where the trainings/trainers meet the trainings and competencies established by the State Collaborative, those entities could do the following:

- 1. send curriculum to Training and TA Committee for review,
- 2. provide video of a training at a later date (once the curriculum is approved)

Concerns?:

- 1. How much can trainers charge providers for these trainings? We don't want trainers to charge extreme prices for these trainings, as they are really public domain.
- 2. What role/authority does SC have in this whole process with relation to the Division of MHDDSA?
- 3. So what if providers aren't able to get this training in time, will they not be able to bill for Day Treatment/Intensive In Home?
- 4. How will SC provide continuous monitoring, would that be our role?
- 5. How do we ensure fidelity to the model during training, follow-up, and for years afterwards?
