In particular: Families United will ensure the online training maintenance fees are covered by Families United as necessary for the second full year of the project, July 2011-June2012.</p> <p>What kinds of System of Care/Child and Family Team training will qualify for Intensive In Home and Day Treatment Medicaid service definitions?
