1. Welcome & Introductions

3a. Discussion Topics/ Presentations	<p>Meeting participants expressed their appreciation to the NC Psychological Association for allowing us to meet in their conference room, which worked very well for today's meeting. We talked about where to hold future meetings, in light of interest in access from bus routes, adequate parking, A/V support, and the convenience of having the Collaborative's note-taker work at the host organization. We will continue to meet at the NC Psychological Association at least for now.</p> <p>We again discussed options for taking minutes, a vital function given our interest in sharing information with people who cannot attend our meetings in person.</p> <p>Meeting participants reviewed a draft letter to local collaboratives. If we get positive feedback from this letter and feel we have the capacity to respond to additional interest, we will send this letter out to other local collaborative leaders as well, e.g., SHACS, JCPCs, CCPTs – Community Child Protection Teams, Healthy Carolinian Task Forces.</p> <p>Damie Jackson-Diopp is continuing to work on getting our web site operational, and anticipates that it will be functional again by next week.</p> <p>Rebecca will update factual content of our strategic charter this fall. Candice Britt noted the possibility of again accessing national consultants in a year or two when it is time for a substantive review of our strategy. Others were enthusiastic about this possibility.</p> <p>Kimberly Blackshear shared initiatives by the National Center for Child Traumatic Stress (www.nctsn.org), including free online webinars focusing on the various trauma types and tools for including youth and family involvement in program development. Look for the blue bar labeled LEARNING CENTER FOR CHILD AND ADOLESCENT TRAUMA (which leads to info on continuing ed options) and the purple box on the top labeled PRODUCTS for lots of great free resources. In the middle of the main web page, there's also a Knowledge Bank which leads to loads of resources from other organizations.</p>

Collaborative Partner Updates	The group expressed sorrow at the demise of the NC Mental Health Association , a long time and generous ally in our work to serve children and youth with behavioral health needs. We will continue to consider how we might support individuals from the NC MHA as they transition to new organizations.
