- Overview of GAIN and other behavioral health related instruments to streamline coordination of services and improve support to juveniles via the Juvenile Justice Behavioral Health Partnership providing summary assessments on clients and e-based training on “7 Challenges”. Collaborative Discussions

- Gail Cormier , NC Families United requested a letter of support from the collaborative for the NC Families United \$15,000 grant to support a mini conference for the statewide family network
- Gang Prevention sharing included release of report from State Board of Education to Joint Education Oversight Committee, release of \$10 million from the Governor’s Crime Commission for county level gang prevention
- Joe Simmons, DPI shared that he is now Section Chief in the Exceptional Children Division supporting among other areas, Positive Behavior Support as did Diane.
- Connie Parker discussed the NC Community Health Alliance
- Pat Solomon gave an overview of the success of the telepsychiatry program whereby a MD provides support virtually while clinical staff are available in person.
- Discussion around the value to connect to the collaborative and local teams as a safety net allowing for ongoing coordination of delivery of services
- Johna Hughes, UNC School of Social Work gave an overview of the 5 year grant to Child Welfare Agencies which reflects the SOC perspective via leadership and workforce development
