### A Deeper Dive on BH/IDD Tailored Plan with Embedded System of Care Principles:

Within the BH/IDD Tailored Care Management Provider Manual, System of Care was noted and intertwined in the responsibilities of the Advanced Medical Home Plus (AMH+) and Care Management Agency (CMA). Two particular portions were addressed: requirements for System of Care and strategies for AMH+s and CMAs utilizing System of Care. Specifically, the requirements of incorporating System of Care principles for BH/IDD Tailored Plan members aged 3-21 include:

- Involving a Child and Family Team (CFT) in the care plan development;
- Using strengths assessments to strategize the needs of the youth and family, and;
- Updating the care plan to be responsive to changes with the youth and family and results of the services and supports provided.

Additionally, AMH+s and CMAs must utilize strategies consistent with the System of Care guiding principles. This includes knowledge of child welfare, school, and juvenile justice systems and their involvement with the children. Among the children and youth receiving behavioral health services it includes:

- Promoting family-driven, youth-guided service delivery;
- Developing strategies that maximize the skills and competencies of family members to support self-sufficiency in youth and the caregivers;

- Allowing services and supports to be delivered in the community and family, using the least restrictive settings as possible; and,
- Implementing proactive and reactive crisis plans to anticipate the needs and supports the individual may have prior to crisis.

# Feds Offer Medicaid Block Grant "Healthy Adult Opportunity" for Medicaid Expansion Population:

The Centers for Medicare and Medicaid has published an executive order that allows States to apply for a Medicaid block grant program beginning on January 30th called "Healthy Adult Opportunity." The program allows states to convert a portion of Medicaid into block grants for "able-bodied" adults 19-64 years old who are a part of the Medicaid expansion population. This block grant option would not impact Medicaid eligibility for individuals who qualify for Medicaid based on a disability or who are in need of long term care services and supports. It is geared toward adults who are presumably able to work.

States will have the opportunity to:

- Set additional conditions of eligibility that promote state and federal program objectives, like community engagement
- Establish flexible cost-sharing structures within broader federal limits
- Choose a lower income standard for eligibility or limit to a subset of individuals (e.g., individuals with substance use disorder) at the regular federal

States that choose this block grant option will be given a specified amount to serve that Medicaid population and are responsible for any spending outside of the block grant amount. The administration argues that this will allow states to more closely monitor their spending and focus their efforts on the most vulnerable populations. In North Carolina, the General Assembly would still need to take some action on closing the insurance gap through expansion of Medicaid to be eligible for this block grant. To be clear, states that have already expanded Medicaid to close the insurance gap may continue as they have in the past. The NC House is considering a bill, <u>H655</u>, which does focus on expanding Medicaid with work requirements.

# NC DHHS published a framework of the expectations for LME/MCOs applying to be BH/IDD Tailored Plans. Comments are due by February 14, 2020.
